- Q. What else happened in the Legislature besides the Bottle Bill update and the "Cool Schools" Bill?
- A. Oregon's e-Waste collection program has been expanded to <u>eventually</u> include these peripherals: <u>printer</u>, <u>keyboard</u> and <u>mouse</u>, <u>AND</u> the legislature helped to secure funding that will establish a fledgling system of marine reserves along Oregon's coast to protect our fisheries and coastal economy.
- Q. What else is happening around here that you should know?
- A. We are now accepting documents that need shredding at our monthly hazardous waste events with Gorge Security Shred's rolly carts. Documents are physically shredded at their business location up Thomsen Road out of HR.

LEGISLATIVE UPDATE

5 months of work in the Legislative Session came to a close June 30, 2011 with the passage of 2 top environmental priorities:

- Modernizing Oregon's Bottle Bill which adds beverage containers like sport drinks and teas, reduces confusion among consumers about which bottles are included, and will increase recycling rates of containers that would otherwise end up in the landfill or as litter.
- 2) "Cool Schools" Bill creates more sustainable schools that use energy and water more efficiently, improves indoor air quality and acoustics, and reduces harmful toxics while creating jobs, saving money on energy bills and creates healthier learning environments.
